# Attend a Colorado PERA Meeting

## Which Meeting is Right for You?

Colorado PERA Field Education Representatives will be traveling across the state offering a variety of PERA meetings to PERA members at various stages in their careers. It's your chance to hear first-hand about your PERA benefits from those who know PERA best. If you have never attended a PERA meeting, consider going to a meeting near you. Information about the different meetings PERA offers is listed below to help you decide which meeting is suitable for you.

### 401(k) Meetings (401(k))

A general overview of the Colorado PERA 401(k) Plan; discussion topics include deferral limits, funds available, administrative fees, loans, rollovers, distribution times and choices, taxation, and penalties.

**Who Should Attend?** Members considering additional retirement savings or who wish to later purchase service credit.  
**Length of Meeting:** One hour  
**Reservation:** Not needed (except required for Denver, Westminster, and Colorado Springs locations)

### Benefit Information Meetings (BIM)

A comprehensive outline of PERA benefits.

**Who Should Attend?** Members at any stage in their PERA careers, especially those within 5-10 years of retirement (members are strongly encouraged to attend this meeting prior to scheduling a Group Workshop or Individual Appointment).  
**Length of Meeting:** Two hours  
**Reservation:** Not needed (except required for Denver, Westminster, and Colorado Springs locations)

### Group Workshops (GW)

Informal question-and-answer sessions open to 12 members (plus spouses) to better understand PERA programs at any stage of retirement planning.

**Who Should Attend?** Members at any stage who want a more interactive opportunity to clarify PERA retirement information. (Members should attend a Benefit Information Meeting prior to attending a Group Workshop.)  
**Length of Workshop:** 90 minutes  
**Reservation:** Required

### Individual Appointments (IA)

Appointments are available to PERA members to discuss anything related to their PERA membership or benefit calculation before retiring. **It is not a requirement to meet with PERA staff prior to retiring.** (Members should attend a Benefit Information Meeting prior to scheduling an Individual Appointment. Individual Appointments are conducted by PERA Benefit Counselors.)

**Who Should Attend?** Available for any member.  
**Length of Appointment:** 45 minutes  
**Reservation:** Up to 24 hours before the scheduled date

### PERACare Information Meetings (PCI)

Learn about the PERACare Health Benefits Program including eligibility, pre-Medicare and Medicare plan choices, prescription benefits and other topics. (Members are encouraged to attend a Benefit Information Meeting prior to attending a PERACare Information Meeting.)

**Who Should Attend?** Members who are near retirement and researching health care options.  
**Length of Meeting:** 90 minutes  
**Reservation:** Not needed (except required for Denver, Westminster, and Colorado Springs locations)

### Purchasing Service Credit Workshops (PSC)

Review requirements and other information to aid members in deciding whether or not to purchase service credit. (Members are encouraged to attend a Benefit Information Meeting prior to attending a Purchasing Service Credit Workshop.)

**Who Should Attend?** Any member who plans to purchase service credit.  
**Length of Workshop:** One hour  
**Reservation:** Not needed (except required for Denver, Westminster, and Colorado Springs locations)

### Retirement Process Meetings (RPM)

Review the fundamentals of PERA benefits and learn about required PERA retirement forms and post-retirement issues. (Members are encouraged to attend a Benefit Information Meeting prior to attending a Retirement Process Meeting.)

**Who Should Attend?** Members who plan to retire within the next six months.  
**Length of Meeting:** 90 minutes  
**Reservation:** Not needed (except required for Denver, Westminster, and Colorado Springs locations)

Reservations are only needed for Group Workshops, Individual Appointments, and meetings held at PERA's Penn Center, Pointe, and Colorado Springs locations.

- Individual Appointments can be made up to 24 hours before the scheduled date.

- Individual Appointments are also available the first Saturday morning of each month at the Denver office and the first and third Saturday mornings at the Westminster office (see back page).

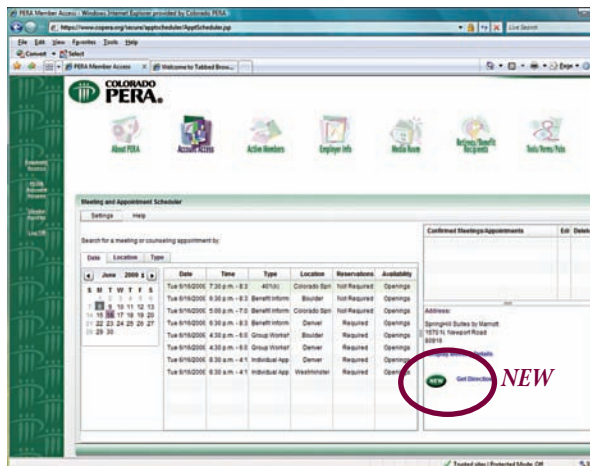
